DOMESTIC APPLICATION

1. Using easy applicator, create a barrier through which cockroaches and other insects must crawl.
2. Any powder visible after application may be brushed into cracks and crevices or removed. Apply only in areas inaccessible to children and pets.
3. Drill 13 mm holes at the top of kick panels beneath cabinets in kitchens and bathrooms. Dust liberally.
4. Apply in void areas accessible due to cracks and holes around plumbing.
5. Apply under bookshelves and in drawer wells of cabinets.
6. Dust into pits of trash chutes.
7. In storerooms, dust under pallets and behind boxes.

DISPOSAL: Do not reuse empty container. Wrap and dispose of empty container with household garbage.
