FIRST AID:

IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions may be needed.

DISPOSAL:

1. Triple or pressure rinse the empty container. Add the rinsings to the treatment site.

DIRECTIONS FOR USE

GROTAN* U-15 Metalworking Micro-biocide is added to metalworking fluids at concentrations of 250 to 1000 mL per 1000 L (250 to 1000 ppm GROTAN* U-15 Metalworking Micro-biocide). Ideally, this preservative should be dispensed into the use-dilution of the metalworking fluid by a metering pump and uniformly dispersed throughout the system.
