This insecticide is for use only in an automatic aerosol dispenser (Cam Spring Action Type), which releases 54.9 mg. of insecticide every 15 minutes. The continuous use of this insecticide will reduce flying insect populations (flies, and mosquitoes) within a few hours. One can protect a room up to 170 cubic metres for up to 30 days.

USE AREAS: Restaurants, Food Processing Plants (not in operation), Hospitals, Food Service Establishments, Lodges, Resorts, Dairies, Horse Stables, Beef Barns, Dairy Barns and Poultry Houses while they are in operation. Also for use in Meat Processing Plants when not in operation. Use area must have at least 170 cubic metres of free flow air space.

DIRECTIONS FOR USE: Dispenser must be located 2-3 metres above the floor at a point where air circulation will carry particles throughout the area. Do not install directly over food or food packaging surfaces. To install can, remove protective cap and insert into dispenser. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. In meat packing plants, DO NOT apply when a food/feed processing facility is in operation. No exposed meat products, ingredients or packaging materials to be left in the room. Any treated surface that may contact meat food products should be washed and rinsed thoroughly with potable water after spraying and before re-use. **DO NOT** apply when a food/feed processing facility is in operation.
