DIRECTIONS FOR USE: 1) Crack and crevice treatment: Lightly coat the areas where insects are found and may hide such as cracks and crevices, around pipes and drainage systems, window frames, floorboards and entrance ways. Apply Chemfree Insectigone Insect Control Powder for Use in Flour Mills at a rate of 500 g/100 m² with a manual dust applicator. Hit insects directly where possible. Repeat treatment if pests re-appear or after cleaning. Do not apply in a manner that may contact grain destined for export.

2) Empty bin treatment: Lightly coat the walls and floor of empty clean bins to control residual insect populations. Do not exceed the rate of 2 kg per bin. Repeat as necessary or each time bin is emptied. Before adding grain that may be destined for export to a treated bin, remove Chemfree Insectigone Insect Control Powder for Use in Flour Mills residue from bin to avoid contact with grain.

3) Grain treatment: For domestic grain, treat grain or seed evenly at the application rate of 500 g/ton as it is being transferred into storage bins or silos. **NOTE:** tests have shown that direct application of Chemfree Insectigone Insect Control Powder for Use in Flour Mills to grain may reduce test weight, grade and flowability of grain. Not to be used in grain destined for licensed transfer elevators or for export without prior arrangement between the purchaser of the grain and the Canadian Grain Commission.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing dust. Do not use as a general space spray. Avoid contact with eyes. Wear a suitable dusk mask approved by NIOSH/MSHA when handling. For application to stored grain or when using a dust blower, wear a NIOSH-approved supplied-air respirator (SAR) operated in a pressure-demand or other positive-pressure mode during mixing, loading and application.

Unprotected personnel should not enter the area during application or subsequent cleanup. If this pest control product is to be used on a commodity that may be exported to the U.S. and you require information on acceptable residue levels in the U.S., visit CropLife Canada's web site at www.croplife.ca.

FIRST AID: If in eyes, hold eye open and rise slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
