## **DIRECTION FOR USE:**

**HORSES:** Shake well before using. To repel gnats, stable flies, mosquitoes and hornflies. Apply a light mist sufficient to wet the surface of the hair. To control stable flies, horse flies, deer flies and face flies; apply at the rate of 60 mL per adult horse, sufficient to wet the hair thoroughly. Repeat treatment as needed but not more than once a day. Do not cover horse after treatment. Do not spray on face of animal; wipe on face avoiding eyes and mouth. If irritation appears discontinue use.

**Wipe-on Method for Horses:** Apply with a cloth which is slightly moistened with the product. Use 30 – 60 mL for an adult horse. Repeat as necessary but not more that once a day. Do not cover horses after treatment. If irritation appears discontinue use. **PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN**. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with skin, eyes and clothing. Wash thoroughly with soap and water after handling and before eating or smoking. Do not breathe spray mist. If irritation appears, discontinue usage. Wash contaminated clothing before reuse. Do not contaminate feed, food or water. Contents toxic to fish and birds. Store in original container away from feed and food.
