DIRECTIONS FOR USE:

Deltamethrin Technical Insecticide is registered only for formulation purposes by Bayer CropScience Inc. It is to be used only in the manufacture of an insecticide which is registered under the Pest Control Products Act.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Fatal if swallowed. Harmful if inhaled.

Avoid breathing technical dust or fumes. Wash thoroughly after using and before eating or smoking. Wear protective clothing including goggles and respirator when handling technical material.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters

STORAGE:

Keep in original container during storage. Do not contaminate or store near feed, seed or foodstuffs. Keep away from fire, open flame or other sources of heat.

FIRST AID:

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

IF SWALLOWED:

IF ON SKIN OR CLOTHING:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. IF INHALED:

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. IF IN EYES:

25 KG-Bulk

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
