## **DIRECTIONS FOR USE:**

- 1.** Initial dosage for pool water having no visible algae is 60 mL of **Guardex ALGICIDE 60** per 10,000 L of pool water.
- 2.** Weekly maintenance dosage is 25 mL of **Guardex ALGICIDE 60** per 10,000 L of pool water.
- 3.** For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait at least 24 hours before adding weekly maintenance dosage.
- 4.** For visible algae, when superchlorination is not employed, add 100 mL of **Guardex ALGICIDE 60** per 10,000 L of pool water.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Do not mix with any other chemical. Harmful if swallowed. Avoid contact with skin and eyes.

**FIRST AID:** If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.  
If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.  
If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.  
Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**ENVIRONMENTAL HAZARDS:** Toxic to aquatic organisms

**DISPOSAL:** Do not reuse empty container. Wrap and dispose of empty container with household garbage. For information on the disposal of unused, unwanted product, contact the Provincial Regulatory Agency or the manufacturer. Contact the manufacturer and the Provincial Regulatory Agency in case of a spill, and for clean-up of spills.
