DIRECTIONS FOR USE

TCMTB Liquid Microbicide Concentrate is for use in manufacturing, formulating or repackaging. It is to be used only for the manufacture of industrial microbicides which are registered under the *Pest Control Products Act*.

Formulators are responsible for their own registrations under the Pest Control Products Act.

PRECAUTIONS

DANGER KEEP OUT OF REACH OF CHILDREN

May be fatal if swallowed. Fatal if inhaled. DO NOT breathe sprays or vapours. Corrosive to the eyes and skin. DO NOT get in eyes or on skin. Avoid contact with clothing and the contamination of food. Potential skin sensitizer. Wear safety glasses (goggles), rubber gloves and body-protective clothing.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

TOXICOLOGICAL INFORMATION: Note to physician: Probable mucosal damage following ingestion may contraindicate gastric lavage. Avoid giving alcohol or alcohol related product.

ENVIRONMENTAL PRECAUTIONS: TOXIC to aquatic organisms. DO NOT discharge effluent containing this product into sewers, lakes, streams, ponds, estuaries, oceans or other waters. DO NOT contaminate water, food, or feed by storage or disposal.
