#### **DIRECTIONS FOR USE:**

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT discharge effluent containing this product into sewer systems, lakes, stream, ponds, estuaries, oceans or other waters.

Note: Not intended for use in potable water systems.

<u>RECIRCULATING COOLING WATER SYSTEMS.</u> When used as directed, WC 8317 Bromicide Tablets effectively control algal, bacterial and fungal slimes in commercial and industrial cooling towers; influent water systems such as flow through filters and lagoons; heat exchange water systems, industrial water scrubbing systems, brewery pasteurizer; and industrial air washing systems equipped with a mist eliminator.

**DOSAGE RATES:** Initial Dose. When system is noticeably fouled, add 0.25-0.75 kg/10,000 L of water contained in the system. Repeat initial dosage until at least 1 mg/L bromine residual is established for 4 hours. Subsequent Dose. When microbial control is evident, add 0.1-0.4 kg/10,000 L of water contained in the system. Repeat as needed to maintain at least 1 mg/L bromine residual in the water for at least 4 hours.

<u>PULP AND PAPER MILLS</u>: DO NOT use this product in the production of paper or paper board that will come into contact with food. This product effectively controls algal, bacterial, and fungal slime in pulp and paper mill fresh and sea water influent water systems; cooling water systems, service water systems, white water systems, and other process. Treat water at critical areas in the system process where mixing of the product with influent will be uniform. The frequency and duration of the treatment will depend upon the severity of the problem. Badly fouled process systems must be cleaned before initial treatment.

## **DOSAGE RATES:**

TREATMENT BY SYSTEM VOLUME. Add up to 0.31 kg of this product to 10,000 L, or 32 parts per million, of water in the system.

<u>TREATMENT BY RESIDUAL METHOD.</u> Add sufficient amount of this product to maintain a measured residual up to 5 ppm as bromine. Once biological control is evident, the use of this product normally can be reduced to something less than 1 ppm as bromine. An alternate method of calculating the appropriate level of this product is to estimate the paper mill's daily production, then add, over a 24 hour period, up to 600 grams of this product per dry ton of paper produced over a twenty-four (24) hour period. Test for bromine to verify the level of 5 ppm is not being exceeded.

<u>PRECAUTIONS:</u> KEEP OUT OF REACH OF CHILDREN. Highly corrosive to eyes and skin. Causes skin and eye damage. May be fatal if swallowed. Do not get in eyes, on skin or on clothing. Potential Skin sensitizer. Wear long pants, a long sleeve shirt, chemical-resistant gloves and goggles or a face-shield while cleaning equipment and handling product. Irritating to nose and throat. <u>May be fatal if inhaled.</u> Avoid breathing dust and fumes. Remove and wash contaminated clothing before reuse. For pulp and paper users, wear coveralls in addition to all other required personal protective equipment while placing the product.

## FIRST AID:

**If contact with eyes occurs**: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If contact with skin or clothing**: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled**: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If swallowed**: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
