DIRECTIONS FOR USE:

To be used in the manufacture of a pesticide which is registered under the Pest Control Products Act.

PRECAUTIONS:

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. WARNING. HARMFUL IF SWALLOWED. HIGHLY CORROSIVE. DO NOT TAKE INTERNALLY. Causes eye and skin damage. Irritating to nose and throat. Avoid breathing dust. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Probable mucosal damage may contraindicate the use of gastric lavage. Treat symptomatically.
