DIRECTIONS FOR USE: Dosages and method of application will depend upon the type of equipment to be treated. Initial slug dose: Use 2.4 liters of Magnatrol 43A per 10,000 liters of water. Maintenance slug dose: Use 1.2 to 2.4 liters of Magnatrol 43A per 10,000 liters of water one to three times per week depending of the season or as needed.
