**INSECTS CONTROLLED:** For control of aphids, mealybugs, spider mites, whitefly, soft brown scale, psyllids, rose or pear slugs (sawfly larvae), and earwigs on houseplants, roses, flowers, vegetables, fruits, ornamentals, shrubs, trees or greenhouse plantings.

**DIRECTIONS FOR USE:** Made of selected soaps that have contact insecticidal properties. Apply product as supplied in trigger spray bottle. Spray when insects are first sighted on buds, shoots, stems and undersides of leaves. Apply weekly for 2-3 weeks and thereafter as required. Insects must be sprayed directly to achieve proper control. Product may be used on fruits and vegetables up to and including the day of harvest. Wash fruits and vegetables before eating.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Concentrated soap may cause eye irritation. Avoid eye contact. May cause skin irritation. Do not use on sweetpeas, nasturtiums, delicate ferns or impatiens. If in doubt about a sensitive species,

perform a small-scale test spray before treating entire plant. Do not apply to plants in direct sunlight. To maximize blossom longevity, avoid spraying blossoms during the heat of the day.

**DISPOSAL:** Do not reuse empty container. Wrap empty container and discard in household garbage.

**FIRST AID:** If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.
