

DIRECTIONS FOR USE

To be used only in the manufacture of insecticides which are registered under the *Pest Control Products Act*. This product is to be used with appropriate solvents and/or carriers, and in the case of pressurized products, propellents, to produce an insecticide product.

Mix well in drum before sampling and each use.
