DIRECTIONS FOR USE: BUG KILL is ready to use. Its special formula is nonstaining, and has no conspicuous odour. Water, not petroleum distillate is used as the diluent.

SHAKE WELL BEFORE USING.

Bug Kill is to be used:

INSIDE BUILDINGS to kill ants, cockroaches, brown and American dog ticks, house flies, silverfish, sowbugs and spiders.

ON INDOOR ORNAMENTAL PLANTS to control aphids and whitefly.

ON OUTDOOR ORNAMENTAL PLANT to control aphids, thrips, and leafhoppers.

Restrictions:

DO NOT apply to any body of water, nor contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Avoid application of this product when winds are gusty.

DO NOT contaminate food/feed, nor apply to surfaces that may come into contact with food/feed.

Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

Instructions for inside buildings:

<u>To Kill Ants, Cockroaches, Silverfish, Sowbugs & Spiders;</u> Thoroughly treat inside building surfaces, including cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and

furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes;, around garbage containers; around interior foundations; localized area around garbage cans; localized areas of floors and floor coverings and points of entry (e.g., around windows and doors). For silverfish, also spray the cracks and crevices in bookcases. Remove all objects before treatment of bookcases where books, clothing, toys, towels and other items are stored. Treated bookcases must be dry before replacing stored items.

For ants, also spray trails and nests. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

<u>To Kill House Flies:</u> Spot treatment only. Spray inside building surfaces around points of entry (e.g., screen frames, doors and window frames), around light fixtures and to localized areas of walls, floors and ceilings. Treatment must only be repeated after 7 days if pest problem persists or reoccurs

<u>To Kill Fleas And American and Brown Dog Ticks:</u> DO NOT apply to furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. Spot treatment may be made with this product to pet bedding, or replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. DO NOT SPRAY PETS WITH THIS PRODUCT.

INDOOR ORNAMENTAL PLANTS: DO NOT use on greenhouse ornamental plants. DO NOT apply to plants grown for food or feed. Controls aphids and whiteflies on indoor ornamental plants. Safe to use on most ornamental plants. Before treating delicate ornamental plants such as Coleus and African Violet, spray 1 or 2 leaves. If no effect is noticed after 2 days, it is safe to treat whole plant. Wet upper and lower surfaces thoroughly. Do not spray to run-off. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. DO NOT exceed 2 applications per year.

OUTDOOR ORNAMENTAL PLANTS: Toxic to bees. Do not apply during bloom. DO NOT apply to plants grown for food or feed. Controls aphids, thrips, and leafhoppers on outdoor ornamental plants. Wet upper and lower leaf surfaces thoroughly. Do not spray to run-off. Spray when listed insects are first noticed. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. DO NOT exceed 2 applications per year.

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. Wash thoroughly before eating, drinking and smoking. Remove fish bowls and aquariums from the treated area.
