PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. DO NOT USE ON CHILDREN UNDER 12 YEARS OF AGE. Severely irritating to the eyes. DO NOT get in eyes. Avoid contact with mouth. Avoid contact with rayon, dynele, acetate or plants. May damage furniture finishes, plastics, and painted surfaces. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves, or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C. Keep away from open flame or spark.

If in eyes: hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If ingested: call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
