**DIRECTIONS FOR USE:**

Use only for the manufacture of wood preservative formulations registered under the Pest Control Products Act.

**KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL:**

Strictly observe all precautions for handling and using pesticides. Avoid contact with skin, eyes and clothing. Do not contaminate food, feed or water supplies.
