TREATMENT**

**PULP and PAPER MILL SLIMICIDE**

A microbiocide recommended for the control of bacterial and fungal slime in the production of pulp and paper.

**POINTS OF ADDITION:** Fennosan 103-C should be added at a point in the system to insure uniform mixing such as the beater, hydropulper, fan, or broke storage pump.

**DOSAGE:** Apply 0.15 to 0.55 kg of Fennosan 103-C as supplied per tonne (dry basis) of pulp or paper produced as a slug dose. If needed, repeat daily. Badly fouled systems should be cleaned before initial treatment.

## ENVIRONMENTAL HAZARDS
