**DIRECTIONS FOR USE: OUTDOORS:** This product will help keep dogs and cats away from trees, shrubs, flowers, lawns and patios. Spray regularly on the edges of flower beds, trunks of trees, base of shrubbery and evergreens and patches of lawn. **SPRAY LIGHTLY EVERY DAY.** Clean up feces and then spray area. Also spray over urine deposits. This will reduce the attraction of stray animals. Always keep the areas clean and use Spray-Pak Repellent to keep animals away. **DO NOT SPRAY DIRECTLY ON FOLIAGE OR SHRUBS OR FLOWERS.** Apply only in areas adjacent to buildings. Do not apply in wildlife habitat areas (e.g., parklands, forested areas).

**INDOORS:** This product will help keep pets away from furniture, chairs, couches, carpets and draperies. To keep pets away from furniture spray lightly on object to be protected. Before spraying extensive areas of carpets or objects, it is recommended to test a small inconspicuous area. This product may stain certain fabrics and soften certain plastics. If this is the case, lightly spray a separate piece of cloth and place it near the area to be protected. Repeat spray as necessary.

**PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. CONTENTS UNDER PRESSURE. DO NOT** place in hot water or near radiators, stoves or other sources of heat. **DO NOT** puncture or incinerate container even when empty. **DO NOT** store at temperatures over 49 deg C. Avoid contamination of food, feed, utensils and water. **DO NOT APPLY TO FOOD/FEED CROPS OR ANIMALS.** Avoid inhalation or exposure of concentrate to eyes. Avoid contact with skin. Wear rubber gloves when applying this product by hand. Always wash hands after using this spray.

Do not apply this product in a way that it will contact any person or pet, either directly or through drift. Do not allow persons or pets to enter treated area until spray has dried.

**FIRST AID:**

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** When empty, press valve and release all pressure. Wrap in newspaper and discard empty container in household garbage. Do not puncture or incinerate.
