## FIRST AID

## PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN.

Causes eye and skin irritation. DO NOT get in eyes or on skin. Do not breathe spray mist.

Keep product away from fire, open flame, lighted electric bulbs and other sources of heat. Do not allow water to be introduced to contents of this container. Wear chemically resistant gloves when handling.

## STORAGE

Store away from food and feed and all sources of heat. Keep container closed. Do not allow water to be introduced to the contents of this container.

## PRODUCT INFORMATION

TURBOCHARGE® Adjuvant is an emulsifiable oil product. It is designed for use as a spray tank adjuvant for use with Achieve® Liquid Herbicide, Liquid Achieve SC Herbicide and Challenger Herbicide on wheat and barley; with REFLEX® Herbicide alone or with VENTURE® Liquid Herbicide on soybeans; and with FLEXSTAR® GT Herbicide on glyphosate-tolerant soybeans.

## DIRECTIONS FOR USE

On wheat and barley, TURBOCHARGE Adjuvant must always be used with Achieve Liquid Herbicide, Liquid Achieve SC Herbicide or Challenger Herbicide. Use as a 0.5% v/v adjuvant (0.5 L TURBOCHARGE Adjuvant per 100 L of spray mixture). Refer to the Achieve Liquid Herbicide, Liquid Achieve SC Herbicide or Challenger Herbicide labels for further details on rate of use and mixing instructions.

On soybeans, TURBOCHARGE Adjuvant must be used with REFLEX Herbicide alone or with REFLEX Liquid Herbicide + VENTURE L Herbicide tank mix. Use as a 0.25% v/v adjuvant (0.25 L TURBOCHARGE Adjuvant per 100 L of spray mixture). Refer to the REFLEX Herbicide or VENTURE L Herbicide labels for further details on rate of use and mixing instructions.

On glyphosate-tolerant soybeans, TURBOCHARGE Adjuvant must be used with FLEXSTAR GT Herbicide. Use as a 0.25% v/v adjuvant (0.25 L TURBOCHARGE Adjuvant per 100 L of spray mixture). Refer to the FLEXSTAR GT Herbicide label for further details on rate of use and mixing instructions.
