DIRECTIONS FOR USE: Drain tank and clean periodically with HUMIDICLEAN Humidifier Cleaner, when refilling the tank add 5 milliliters of the Original BT for every 4 liters of water. Repeat the process when refilling the tank.

NOTE: Use HUMIDITREAT to eliminate lime scale build-up on tank and filter to insure longer, efficient, trouble free performance for your humidifier.

FIRST AID
