DIRECTIONS FOR USE: To be used only in the manufacture, formulating, repackaging or repouring of a pest control product that is registered under the *Pest Control Products Act*.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS TO UNAUTHORIZED PERSONEL. May be harmful if swallowed, inhaled or absorbed through The skin. Avoid breathing vapors. Avoid contact with skin, eyes or clothing.

If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If the person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically. The Acute Oral Toxicity LD50 is greater than 5000 mg/kg.

STORAGE: Keep in original container during storage. Store in a cool, dry place away from seed, feed, fertilizers or other pesticides.
