Always take container label with you when seeking medical attention. **If in eyes:** hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If ingested:** Call a poison control centre or doctor immediately for treatment advice. Do NOT induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. **If inhaled,** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically. This product contains petroleum distillates. Vomiting may cause aspiration pneumonia.

DISPOSAL: When container is empty, press valve to release all remaining pressure. Discard empty container in household garbage.
