DIRECTIONS FOR USE

For manufacturing use only. BARQUAT MB-80W is a MANUFACTURING CONCENTRATE for formulating purposes only. Formulators are responsible for their own registrations.

This product should not be used or compounded with any reducing or oxidizing agents (such as calcium hypochlorite, solid perchlorate or nitric acid) since such mixtures may be explosive. Do not use in conjunction with soap or any anionic wetting agent. Wear goggles or face shield, rubber gloves and respirator if mist is generated. Under certain conditions, the use of protective creams may be advisable. Wash thoroughly after handling.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Danger - Corrosive to eyes. Do not get in eyes, on skin or clothing. Harmful if swallowed. Avoid contamination of food.

FIRST-AID:

In case of contact on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed. Avoid alcohol.
