PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Avoid contact with eyes, skin and clothing. Harmful if swallowed. May cause eye or skin irritation. Do not inhale vapours. Wash well after handling and before eating, drinking or smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes.

PHYSICAL OR CHEMICAL HAZARDS

COMBUSTIBLE. Do not use or store near heat or open flame. Do not weld or cut container.

FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

The decision of whether to induce vomiting or not should be made by an attending physician. If lavage is performed, suggest endotracheal and/or oesophageal control. Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach. This product contains petroleum distillates. No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

AGRICULTURAL CHEMICAL

Do not ship or store with food, feeds, drugs or clothing.

ENVIRONMENTAL HAZARDS
