**DIRECTIONS FOR USE:** To be used only in the manufacture of pesticides which are registered under the Pest Control Products Act. Formulators are responsible for their own registrations.

Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
