DIRECTIONS FOR USE

Cooling Towers, Heat Exchangers, Condensers, Air Washers: Prior to use, systems should be cleaned to remove organic, inorganic and microbiological deposits. An initial slug addition (shock) of 100 ppm active ingredient based on the water content of the system is recommended. Repeat the initial dosage until microbial activity control is evident. Subsequent additions of 15 to 50 ppm active ingredient should be made every 1 to 5 days or as needed. Note: For air washers use only in systems equipped with effective mist eliminating components.

Metal Working Fluids: Dose at 0.6 - 1.2 kg per 10,000 litres of system volume. Expel product directly into the sump at a convenient point.

Oilfield Application: Use 100 ppm active ingredient based on the water content of the system until control is achieved. Maintenance dosage is 10-25 ppm. In all applications, expel the product into the system in the areas as specified in the following:

Gas Wells: Introduce through wellhead valving system in order to drop product down tubing.

Oil Wells: Drop down tubing when sucker rods are pulled.

Storage Tanks: Drop through thief hatch.

PRECAUTIONS

DANGER KEEP OUT OF REACH OF CHILDREN

Corrosive to eyes and skin. Fatal if swallowed. POTENTIAL SKIN SENSITIZER. Do not swallow. Do not inhale dust. Do not get in eyes, on skin or clothing. Avoid contamination of food. Wear goggles or a face shield, chemical-resistant gloves, long pants, a long-sleeved shirt, shoes and socks during mixing/loading, clean-up and repair. Formaldehyde can be released during use of this product. It is recommended that this product not be used in circumstances that would result in formaldehyde air concentrations in the workplace exceeding the exposure levels established by occupational health and safety authorities in your jurisdiction. If values exceed this level, it is recommended that NIOSH approved respiratory protection be worn. Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Users should remove clothing/protective equipment immediately if pesticide comes in contact with skin through soaked clothing or spills. Then, wash skin thoroughly and put on clean clothing and required protective equipment prior to resuming your previous work activity. Discard clothing or other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them.

FIRST AID

Eye exposure: Hold eye open and rinse slowly and gently with water for 15–20 minutes.

Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

Call a poison control centre or doctor for treatment advice.

Skin or clothing exposure: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

Inhalation: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Ingestion: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Note to physician: This product is corrosive. Probable mucosal damage following ingestion may contraindicate gastric lavage. This product may produce a sensitization response or an allergic reaction in some individuals.

DISPOSAL
