DIRECTIONS FOR USE:

Add 20.5 ml (1 ounce) of N.F.T.D. to each 10.0 litres (3 gal imp.) of water in the make-up tank or to the holding tank.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN.

Handling: this product can cause skin and eyes irritation. Avoid all contact with skin, eyes and clothing. Wear safety glasses, chemical-resistant gloves, long pants, a long-sleeved shirt and shoes when handling this concentrate.

Storage: Do not store near potable water and food.

Disposal:

- 1) Triple or pressure-rinse the empty container. Add the rinsings to the treatment site.

Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container label, or product name and Pest Control Product Registration Number with you when seeking medical attention.
