DIRECTIONS

Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices for insect control. If reinfestation occur, repeat applications as necessary. Use as a surface spray. Provide adequate ventilation after indoor use. KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.

INDOOR USE: Thoroughly treat cracks, crevices and spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen.
