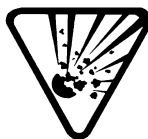

FIRST AID:

If signs continue, consult a veterinarian immediately.

DIRECTIONS FOR USE:

Zodiac Mousse is a contact and residual insecticidal foam which kills adult cat fleas, dog fleas, American dog and brown dog ticks. Effectively breaks the flea life cycle and prevents the growth of pre-adult stages of the flea. Its unique combination of ingredients kills adult fleas for 7 to 10 days and keeps the flea eggs from hatching for up to 45 days.

FOR USE ONLY ON DOGS AND CATS

Use Limitations

DO NOT use on puppies or kittens less than 8 weeks old.

DO NOT USE ON ANY OTHER ANIMAL.

Consult a veterinarian before using on sick, aged, pregnant or nursing animals or animals receiving drug or other pesticide treatment.

This product contains Pyrethrins, Piperonyl Butoxide and (S) Methoprene. **DO NOT** apply another pest control product such as a shampoo, spot on, collar or powder which contains Pyrethrins, Piperonyl Butoxide and (S) Methoprene to the treated animal when using Zodiac Mousse.

DO NOT use this product more often than once every month. Treatment must only be repeated if pest problem reoccurs.

To kill dog fleas, cat fleas, brown dog ticks and American dog ticks:

DO NOT administer by mouth. Shake can well before using. Hold can about 2 cm above pet's back and spray the entire body of the pet, beginning at the head and working towards the tail. Ticks are difficult to control and must be sprayed directly. Pay special attention to neck, hindquarters, areas under legs, around the tail and between toes. **DO NOT** apply to pet's face, eyes, nose, mouth or genitals. Rub the foam thoroughly into the pet's coat using a comb, brush or fingertips in an amount which moistens, but does not soak the coat. Wipe off any excess product from the pet with a dry cloth and then comb or brush. Using this technique, the application of 2 to 4 grams of Zodiac Mousse per kilogram of body weight (i.e., 1 to 2 strips of foam down the pet's body length) will provide effective long-term flea control.

For effective flea and tick control, treatment of the pet should be combined with sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas. If pest problems persist, a premise treatment with an insecticide labelled for that use may be

required (e.g., Zodiac premise products). A veterinarian should be consulted when pest infestation continues to be a problem on the pet. The use of an effective product for controlling adult and larva flea populations in the pet's environment will reduce the possibility of re-infestation of the animal.

STORAGE: Store this product away from food or feed. Contents under pressure. **DO NOT** puncture container. **DO NOT** expose to temperature over 50°C. Keep away from heat or open flames.

DISPOSAL: DO NOT reuse the empty containers. Dispose in household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.
