DIRECTIONS FOR USE

Oilfield Applications: Inject continuously at 100 ppm active ingredient based on water content of oil and gas field water systems until bacterial control is achieved. Inject at a point that will ensure uniform mixing.

Maintenance dosage: 10 - 25 ppm.

PRECAUTIONS

DANGER KEEP OUT OF REACH OF CHILDREN

Corrosive to eyes and skin. Fatal if swallowed. POTENTIAL SKIN SENSITIZER. Do not swallow. Do not inhale aerosols or vapors. Do not get in eyes, on skin or on clothing. Avoid contamination of food.
