Avoid contact with eyes and mouth. Do not open protective pouch until ready to use. After prolonged storage, a small amount of liquid may form on the strip. Avoid contact with eyes, mouth and skin. Wear chemical-resistant gloves when opening insect traps and for disposal of the pest strip. Wash hands thoroughly with soap and water after handling strip. Do not contaminate water by cleaning of equipment or disposal of wastes. Read Directions for Use accompanying the pheromone trap before opening the VAPORTAPE II package. For Use by Pest Control Operators only. The pest control operator must post and provide an information sheet to all occupants of buildings where the product is to be used.

Toxic to aquatic organisms

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice. **If swallowed,** call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Dichlorvos is a cholinesterase inhibitor. Typical symptoms of overexposure to cholinesterase inhibitors include headache, nausea, dizziness, sweating, salivation, runny nose and eyes. This may progress to muscle twitching, weakness, tremor, incoordination, vomiting, abdominal cramps and diarrhea in more serious poisonings. A life-threatening poisoning is signified by loss of consciousness, incontinence, convulsions and respiratory depression with a secondary cardiovascular component. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate degree of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as Pralidoxime Chloride, may be therapeutic if used early; however, use only in conjunction with atropine. In cases of severe acute poisoning, use antidotes immediately after establishing an open airway and respiration. With oral exposure, the decision of whether to induce vomiting or not should be made by an attending physician.

DIRECTIONS FOR USE

HERCON VAPORTAPE II is to be used only as a toxicant strip in insect pheromone traps for the following insect pests: gypsy moth, spruce budworm, forest tent caterpillar, Mediterranean fruit fly; and codling moth and other lepidopterous pests of vegetable and fruit crops. For outdoor use only. Not for use in residential areas. Residential areas are defined as any use site where bystanders including children could be present during or after application. This includes around homes, schools, public buildings or any other areas where the general public including children could be present. Do not use strips for any other purpose Replace strips after 12 week.

RESISTANCE MANAGEMENT RECOMMENDATIONS

For resistance management, please note that <u>VAPORTAPE II INSECTICIDAL STRIPS</u> contains a Group 1B insecticide. Any insect population may contain individuals naturally resistant to <u>VAPORTAPE II INSECTICIDAL STRIPS</u> and other Group 1B insecticides. The resistant individuals may dominate the insect population if this group of insecticides is used repeatedly in the same locations. Other resistance mechanisms that are not linked to site of action but are specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed. To delay insecticide resistance:

- Where possible, rotate the use of <u>VAPORTAPE II INSECTICIDAL STRIPS</u> or other Group 1B insecticides with different groups that control the same pests.
- Avoid application of more than the indicated number of <u>VAPORTAPE II</u> <u>INSECTICIDAL STRIPS</u> or other insecticides in the same group in a season.
- Insecticide use should be based on an IPM program that includes scouting, record keeping and considers cultural, biological and other chemical control practices.
- Monitor treated pest populations for resistance development.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance-management and/or IPM recommendations for the specific site and pest problems in your area.
