## DIRECTIONS FOR USE

DO NOT apply indoors as a broadcast application. ONLY spot or crack and crevice applications are permitted indoors in residential areas. Spot application is localized to a surface area not more than 0.2 m<sup>2</sup>. Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

DO NOT apply to furniture, mattresses, linens, toys or clothing.

DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces, small storage rooms, closets).

Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air.

DO NOT apply when people or pets [or livestock] are present.

DO NOT allow people or pets [or livestock] to enter treated areas until sprays have dried

DO NOT allow spray to drip or allow drift onto non-target surfaces.

DO NOT apply as a space spray.

DO NOT apply to any body of water.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Avoid application of this product when winds are gusty.

When applied to the exterior surfaces of buildings, porches, patio and decks, DO NOT treat soil, turf or other plants adjacent to the structure.

DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed.

SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS. DO NOT USE TETRAMETHRIN IN FOOD HANDLING, STORAGE, OR PREPARATION AREAS WHILE FOOD IS PRESENT.

USE ONLY FOR SPOT, OR CRACK AND CREVICE APPLICATIONS.

### INDOOR USE:

To Kill Ants, Carpet Beetles, Cockroaches, Crickets, Earwigs, Silverfish, Sowbugs and Spiders: Spray as a spot application to indoor building surfaces, including dark corners of rooms; cracks and crevices in walls, floors and ceilings; along baseboards and door and window frames; around sinks; to walls behind and floors beneath appliances (e.g., stoves, refrigerators) and furniture (e.g., cabinets); around garbage cans, plumbing and other utility installations; around points of entry (e.g., windows, doors). Apply as a crack and crevice application using the pin-stream setting to apply small amounts of this product directly into the cracks and crevices found between different elements of construction, between equipment and floors, openings leading to hollow spaces in walls and furniture legs. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To Kill Brown Dog Ticks and Fleas: DO NOT SPRAY PETS WITH THIS PRODUCT. Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control, treatment of the pet should be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding area. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. Pet bedding may be entirely treated with this product or replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

### FOR OUTDOOR USE ON THE EXTERIOR SURFACES OF BUILDINGS AND ON PORCHES, PATIOS AND DECKS:

House Flies and Mosquitoes: Use only out of doors as an aid in reducing annoyance from these insects. For use as a spot application on the exterior surfaces of buildings (including garages) and porches, patios and decks. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where insects enter (e.g., screens, doors, window frames). House Flies and mosquitoes coming to rest on treated surfaces will be killed. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

### PRECAUTIONS:

Keep out of reach of children and pets. Remove animals for a minimum of 1 hour when spraying room. Following treatment, ventilate all rooms, do not access for a minimum of 15 minutes and do not re-enter before ventilation is complete. Avoid contact with treated surfaces until dry. Avoid contact with eyes, skin and clothing. Harmful if swallowed. May cause eye or skin irritation. Do not inhale vapors. Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes.

Vinyl and Aluminum Siding: The application of this product to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Before applying to vinyl or aluminum siding, treat a small area and evaluate 30 minutes later to allow any potential staining to occur. Regardless of the test results, do not apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of the day.

FIRST AID: If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. In case of skin or clothing contact: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. In case of eye contact: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention. In case of Medical emergencies or health and safety inquiries, or in case of fire, leaking or damaged containers, information may be obtained by calling 1-888-740-8712.

TOXICOLOGICAL INFORMATION: The product contains petroleum distillates. Vomiting may cause aspiration pneumonia. Treat symptomatically.

ENVIRONMENTAL PRECAUTIONS: Toxic to aquatic organisms. Toxic to birds. Toxic to bees. Toxic to beneficial insects. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.

PHYSICAL OR CHEMICAL HAZARDS: Contents under pressure. Keep away from heat, sparks, open flame. Do not puncture or incinerate container. Exposure to temperatures above 50°C may cause bursting.

DISPOSAL: Do not reuse empty container. Wrap container in several layers of newspaper and discard in household garbage.
