### **DIRECTIONS FOR USE:**

Apply Green Earth<sup>®</sup> Hose-Spray Insecticidal Soap using the hose-end applicator attached. It will accurately dilute this concentrated insecticide for treatment of vegetables, fruits, flowers, trees and shrubs.

- 1. Read the complete label for application instructions and precautions before using.
- 2. Shake container thoroughly before attaching to garden hose. Ensure sprayer is set to the "OFF" position.
- 3. Turn water supply on at the source. Water pressure will build in hose since the sprayer is already in the "OFF" position.
- 4. To apply product, bend safety tab and turn the control valve clockwise to the "ON" position.
- 5. For best results, hold sprayer and bottle level.
- 6. When spraying is complete, turn the control valve counterclockwise to the "WATER" position. Flush with water to clean the sprayer head, then turn the control valve to the "OFF" position. Turn water supply off. Disconnect hose from applicator and store remaining product in original container.

**NB:** "WATER" position is to be used only for cleaning sprayer head.

**APPLICATION:** Vegetables, Fruits, Flowers, Trees, Shrubs. To control aphids, mealybugs, spider mites, whiteflies, earwigs, soft brown scale, psyllids, rose and pear slugs.

Spray to thoroughly wet both sides of leaves and stems. Repeat applications weekly until control is observed. Not recommended for use on Ferns, Nasturtium and Sweet Peas. If in doubt about any delicate plant such as **roses**, **seedlings** and **transplants**, apply to several leaves as a pretest. Allow sufficient time to determine if plant damage occurs before spraying the entire plant. Do not spray open blooms. Do not apply during full sun or high heat.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Wash fruits and vegetables before use. Avoid skin and eye contact.

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and P.C.P. Registration Number with you when seeking medical attention.

## TOXICOLOGICAL INFORMATION: Treat symptomatically.

**DISPOSAL:** Do not reuse empty container or applicator. Recycle empty container. Wrap and discard spray applicator with household garbage.
