**PUNCH ALL 4 SIDE HOLES**

**DIRECTIONS:** Place traps in house where ants are running and outside where ants enter dwelling. For heavy infestations, place traps 1.5 to 3 m apart. Replace with new traps as needed. Ants enter traps and carry bait back to their nest; usually kills entire colony.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN AND DOMESTIC ANIMALS. HAZARDOUS IF SWALLOWED. Do not remove lid of container. Do not contaminate feed or foodstuffs.
