## **PRECAUTIONS:**

### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

Corrosive to eyes and skin. Do not get in eyes, on skin, or on clothing. In case of contact, immediately flush eyes or skin with plenty of water. Get medical attention if irritation persists.
