DIRECTIONS FOR USE: RIDS DOGS AND CATS OF FLEAS AND DOGS OF BROWN DOG TICKS AND KILLS DEER TICKS: Do NOT administer by mouth. Use ONLY in well-ventilated areas, preferably outdoors. Shake well before using. Spray the pet from a distance of 10 cm to evenly dampen coat, ensuring entire body coverage, including legs and under the body. Ruffle the haircoat to ensure penetration to the skin. The spray should wet ticks thoroughly. Do not spray in face, eyes, or on the genitalia. Do not soak pet. This product, applied to dogs at the rate of 8 mL/kg, will rid dogs of fleas and brown dog ticks for 6 days and, applied to cats at 18 mL/kg, will rid cats of fleas for up to 10 days. Kills deer ticks which may carry the organism which causes Lyme Disease. Do not repeat in less than 14 days. Reapply every 2 weeks for continual pest control in situations where there is an ongoing risk of pest infestation. For effective flea and tick control, treatment of the pet should be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash pet's bedding, living quarters, and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required.

PRECAUTIONS: HUMANS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Wear rubber gloves during application of this product. Avoid contact with mouth, eyes, skin and clothing. Avoid contact with pet until dry. After handling or applying, wash gloved hands (or any other skin that came into contact with the product) with soap and water. Avoid product contact with food, food utensils or places where food is prepared or stored.

PETS: Harmful if swallowed or inhaled. May irritate eyes, nose and throat. Avoid direct spray of dog's or cat's mouth, face, eyes and genitals. Do not use on nursing females or on animals under 12 weeks of age. Consult a veterinarian before use on pregnant, ill or debilitated animals, or on animals under drug or other pesticide treatment. If adverse effects occur, discontinue use, bathe pet with a non-pesticidal shampoo to remove pesticide residues and thoroughly rinse. If adverse effects persist consult a veterinarian. Toxic to fish and other aquatic life. Cover fish aquaria in vicinity of treatment area. Toxic to birds.

FIRST AID: HUMANS: IF SWALLOWED, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. **IF ON SKIN OR CLOTHING,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **IF IN EYES,** hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **PETS:** Sensitivities may occur after using **ANY** pesticide for pets. If signs of sensitivity occur, bathe the pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. Take the container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE: Store in a cool, dry area.

DISPOSAL: Do not reuse empty container. Wrap container thoroughly and put it in household garbage.
