DIRECTIONS FOR USE PULP & PAPER MILLS

For control of bacterial and fungal slime on pulp, paper, or paperboard machines, add X-CELL-414 Liquid Industrial Microbicide to the stock or white water going to the fan pump in amounts of 25 grams to 500 grams (25 mL to 500 mL) per metric tonne of pulp or paper produced. Addition can be made continuously or intermittently as required to control the slime. Use of a metering pump to feed the product directly from the shipping container is recommended.
