DIRECTIONS FOR USE:

COBRA™WRAP containing copper naphthenate is intended for use only on poles, posts and pilings as a wood preservative treatment. COBRA™WRAP containing copper naphthenate provides protection against moisture, fungal rot and termite damage. This copper naphthenate wood preservative and insecticide will preserve, protect and seal wood surfaces that will be in contact with soil or concrete. Depending upon climatic conditions, species of wood to which applied, moisture and humidity, treatment extends service life several years.

DO NOT apply this product to wood that will be used in water.

DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans and other waters.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

PREPARATION AND APPLICATION

Wood should be clean, dry, well seasoned and free of bark. When using COBRA™WRAP as a groundline treatment excavate around wood to allow top of wrap to extend 5cm (2") above groundline.

Protect eyes and skin from contact.

Wire brush area 7.5cm (3") above groundline removing dirt and decayed material.

Cut off sufficient length of COBRA™WRAP leaving 5cm - 15cm (2" - 6") of wrap to serve as overlap. Lay on ground exposing the pouches of preservative. Peel off top layer exposing the leakable layer below. On the overlap portion leave a sufficient tail attached to the outermost edge forcing preservative to move back into wood zone for penetration.

Wrap proper length COBRA™WRAP around the pole with saturated pad against the pole and staple or tack firmly in place. Staple short side of the backing first and overwrap with longer edge. Allow wrap to extend 5cm (2") above groundline.

Backfill excavation, tamping firmly.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

For exterior use only. Wear rubber or plastic gloves and appropriate covering clothing when applying this product. Wash thoroughly after use with soap and water. Wash thoroughly before eating or smoking.

Harmful if swallowed. Causes skin and eye irritation. Potential skin sensitizer. May be absorbed through skin. Do not get into eyes, on skin or on clothing. Avoid breathing vapour. Use in well ventilated area.

TOXICOLOGICAL INFORMATION

Contains petroleum distillates and copper naphthenate. Treat as for ingestion of kerosene

FIRST-AID

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

SKIN OR CLOTHES CONTACT: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. Wash hands with vegetable oil or hand degreaser and then thoroughly with soap and water.
