If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

DIRECTIONS FOR USE:

Dilution of 1:60,000 (16ml per 1000 litres of water) provides 1 part per million (1 ppm) copper. General: When used as directed, BlueMagic provides extended water protection by eliminating algae and increasing bacterial control capacity of primary disinfectants.

When applied to contaminated pools, BlueMagic kills algae and bacteria gradually (one hour to 1-2 days, depending on the organism). BlueMagic, at 1 ppm copper concentration prevents or inhibits the growth of algae and most bacteria. For best results follow instructions for pool/spa water balancing, (test and adjust pH, Total Alkalinity, and Hardness), oxidize organics, monitor primary disinfectant, and maintain copper level at 0.75 to 1 ppm at all times. A combination of BlueMagic and primary disinfectant results in superior water quality. Monitor copper levels with a copper testing kit. Use a sequestering agent to prevent or eliminate precipitation or staining.

Swimming Pools:

Initial treatment: In early spring- before algae proliferates. Balance the water, then apply 1 L BlueMagic to 60,000 L of water.

Maintenance: Test the Copper level every two weeks and add BlueMagic proportionally to maintain approximately 0.75 to 1.0 ppm of copper. Do not allow copper level to drop below 0.5 ppm. **Winter:** To close pool, raise copper level to 1.2 ppm.

Spas and Hot Tubs:

Use the same application rate as for swimming pools. Elevated water temperatures require more frequent oxidation, water testing and pH / alkalinity adjustments.
