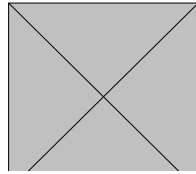


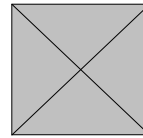

**DIRECTIONS:** When used as directed DELLA-ZAP\* Aerosol controls, flies, mosquitoes, wasps, silverfish, cockroaches, fleas, ants, spiders, crickets, bed bugs, gnats, adult moths and accessible stages of stored product insects.

**FLIES, MOSQUITOES, WASPS, GNATS, SILVERFISH, COCKROACHES, FLEAS, ANTS, SPIDERS, CRICKETS, BEDBUGS:** Close doors and windows. Direct mist upwards to all parts of the room, especially windows and other light sources. Apply for 3 to 5 seconds per 30 m<sup>3</sup> of space. Keep room closed 15 minutes after each treatment. Also direct mist into areas where insects are found.

Do not remain in treated area. Ensure proper ventilation after sealed areas have been treated. Sweep up and destroy dead insects.

**FLYING MOTHS:** Treat all enclosures arranging clothing and other articles so that the mist can circulate freely. Apply for 3 seconds per 30 m<sup>3</sup> of space. Close treated area for at least 45 minutes.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** This dispenser contains a liquid under pressure. Do not puncture container or expose to temperatures higher than 50° C. Do not spray directly on food or utensils. Do not spray in presence of fish, aquatic or other cold-blooded life. Do not use in presence of open flame or spark. Do not use in nurseries or rooms where infants, ill or aged persons are confined. Any treated surface that may contact food or feed products should be washed thoroughly with potable water after spraying and before reuse. Do not contaminate any body of water. Do not spray closer than 1 metre to fabric. Exceeding dosage rates and bi-weekly applications may cause stains on fabrics, furs and other materials. In food processing plants and food service establishments, apply only when the plant is not in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operations. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying.

**DISPOSAL AND DECONTAMINATION:** When container is empty, press valve to release all remaining pressure. Do not puncture or incinerate. Dispose of containers in an approved land fill site in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the manufacturer.

**FIRST AID:** In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention. Do not induce vomiting and obtain
