## **DIRECTIONS FOR USE**

KATHON™ SF-886 TECHNICAL MICROBICIDE is a technical active ingredient for industrial algicides, fungicides, and/or bactericides.

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

## **FIRST AID**

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.
