BottomShield

BottomShield is a premium quality anti-fouling protective paint, resistant to algae, barnacles and other marine fouling. Effective in both fresh and salt water, it is a soft finish and its high copper content provides remarkable anti-fouling properties. It is easy to apply and gives long, effective life. This paint provides excellent performance on high or low speed boats in temperate waters.

DIRECTIONS FOR USE

For use on boats or ships only. For prevention of marine fouling. Application rate is 9.84 square metres per litre (400 square feet per gallon).

Fiberglass:

New fiberglass bottoms must be dewaxed using West Marine #329591. Change rags frequently to remove Dewaxer and contaminants. Sand with 80 to 100 grit paper and prime with two coats of N470 BottomPoxy Primer. To protect against gel coat blistering, apply four to five coats of N470 BottomPoxy Primer.

Wood:

This paint can be applied directly to new wood bottoms after sanding smooth with 80 grit paper. Then apply two coats of BottomShield. Reduce first coat 10% with West Marine #329591.

Metal:

Bring iron and steel to bright finish and prime with two to four coats of N470 BottomPoxy Primer. On previously painted surfaces, loose or flaking spots in the old coating should be cleaned down to bright metal by wire brush, power sanding or sandblasting and immediately spot primed. At least one additional coat of primer should be applied to these spots before finish coating.

NOT FOR USE ON ALUMINUM

Previously Painted Surfaces:

Must be in good condition and clean, cracked, damaged or peeling coatings must be completely removed before painting.

APPLICATION INFORMATION

Stir thoroughly. Allow at least four hours between coats and before launching. Two coats are recommended for best results. If thinning is necessary, use West Marine #329591. West Marine #329591 should be used for cleaning brushes and equipment. Application rate is 9.84 square meters per litre (400 square feet per gallon).

Apply by brush, roller or spray. Temperature should be $10^{\circ}C$ ($50^{\circ}F$) or above. Surface should be dry and clean with loose or flaking paint completely removed. Apply under good drying conditions.

Large vessels (>25m) must be treated by trained applicators.

DO NOT place the painted parts in water after painting until the paint is fully cured (see recommended times on the label). It is recommended that you prevent paint chips or dust caused by removing paint from entering water.

DO NOT apply this product in a way that will contact workers or bystanders, either directly or through drift. Only protected handlers may be in the area during application.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
