For use as a spot, crack and crevice treatment to control insects listed on front panel.

**DIRECTIONS:** SHAKE CAN WELL BEFORE USING. Test a small inconspicuous area of the carpet for colour fastness & staining before full application. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices for insect control. If reinfestation occurs, repeat applications as necessary. Cover fish bowls and remove pets for one hour when spraying. Provide adequate ventilation after indoor use. KEEP PET AND CHILDREN AWAY FROM SURFACE UNTIL DRY.

**INDOOR LISE:** Thoroughly treat cracks, crevices and spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen.

**QUTDOOR LISE:** Spray spots on outside surfaces of screen frames, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter. The cluster flies and house flies will be killed when they land on the treated surfaces.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin, or clothing. DO NOT USE ON HUMANS, PLANTS, ANIMALS, FOOD STUFF, FOOD UTENSILS, FISHBOWLS OR ANIMAL FEED AREAS. DO NOT USE AS A SPACE SPRAY. Do not use in areas where food is handled, prepared or stored. Remove or cover all exposed foods and cooking utensils

before spraying. May cause skin and/or eye irritation. Product is very toxic to fish. Do not contaminate water by improper use or disposal. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat or store at temperatures over  $50^{\circ}$  C.

FIRST AID: If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**DISPOSAL:** When container is empty press valve to release all pressure, then dispose in household garbage. Do not puncture or incinerate.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.
