DIRECTIONS FOR USE:

Do not use in food handling, storage or preparation areas while food is present. Application as broadcast, perimeter/spot, and crack and crevice is permitted.

- 1. Kills fleas and ticks living in carpets and upholstery.
- 2. Press out plastic seal in top.
- 3. Turn top to desired opening.
- 4. Shake powder lightly over entire carpet or area to be treated. 45.4g of product is sufficient to treat one square meter of carpet. Do not use on wet surface.
- 5. Leave powder on for two hours, while ensuring to keep children and pets off treated surfaces.
- 6. Vacuum treated area thoroughly to remove powder (and dead pests). Discard vacuum bag.

FIRST AID:
