DIRECTIONS FOR USE: TO BE USED ONLY IN THE MANUFACTURE OF
MICROBIOCIDES REGISTERED UNDER THE *PEST CONTROL PRODUCTS ACT*

FIRST AID

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

CORROSIVE

CAUSES EYE AND SKIN DAMAGE. DO NOT GET IN EYES, ON SKIN OR ON CLOTHING. AVOID CONTAMINATION OF FOOD. HARMFUL OR FATAL IF SWALLOWED. DO NOT BREATHE DUST. WEAR GOGGLES OR FACE SHIELD AND RUBBER GLOVES WHEN HANDLING. USE WITH ADEQUATE VENTILATION. WASH THOROUGHLY WITH SOAP AND WATER AFTER HANDLING. REMOVE CONTAMINATED CLOTHING AND WASH BEFORE REUSE.

ENVIRONMENTAL HAZARDS

CHEMICAL AND PHYSICAL HAZARDS

Reacts violently with strong bases and strong oxidizing agents. Will decompose slowly above 100°C (212°F) and rapidly above 205°C (401°F) releasing toxic gases. Avoid comminution and dusting.

DECONTAMINATION AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE

Store in a cool, dry, well-ventilated area, in well-closed original containers, away from energy sources, combustible organic materials, oxidizers, strong bases, and moisture. When handling or dealing with spills, use goggles or face shield, body-covering clothes, including impervious rubber gloves and boots; use a dust respirator if dusting occurs.

DISPOSAL
