[Permethrin is a synthetic version of pyrethrins. Pyrethrins have long been known for their low mammalian toxicity and rapid knockdown of insects. Like the pyrethrins on which it is based, permethrin has retained a low level of toxicity to mammals; however, the synthetic process has increased the stability of the chemical giving it residual properties. Although permethrin is more stable than pyrethrins on which it is based, it is still degraded by the ultraviolet rays of the sun. This results in a relatively short residual life in the presence of sunlight; however, when protected from the sun, permethrin will provide residual activity.]

For use as a spot or crack and crevice treatment to control insects listed on front panel.

GENERAL DIRECTIONS: SHAKE CAN WELL BEFORE USING. [Gently insert [or use] the (wand or applicator wand or extension tube or applicator hose or jet tube)[into the spray nozzle before using].] Test a small inconspicuous area of the surface to be treated for color fastness & staining before full application. Do not apply to draperies, wallpaper or similar materials that may be stained. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vapourize into cracks and crevices for insect control. Treatment must only be repeated if pest problem persist or reoccurs. Unpainted or unsealed concrete surfaces may require repeated application after two weeks if

necessary. Provide adequate ventilation after indoor use. **KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.**

DO NOT apply as a space spray or broadcast application. Apply ONLY as a spot or crack and crevice treatment. Spot application is localized to a surface area not more than 0.2 m². Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

Restrictions:

DO NOT apply to any body of water.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Avoid application of this product when winds are gusty.

DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed.

DO NOT apply to furniture (excluding bookcases and storage furniture), mattresses, linens, toys or clothing.

When applied indoors, DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces, small storage rooms, closets).

When applied indoors, ventilate treated areas after application by opening windows and doors, or using fans where required to aid in the circulation of air.

DO NOT apply when people, pets or livestock are present.

DO NOT allow people, pets or livestock to enter treated areas until sprays have dried.

DO NOT allow spray to drip or allow drift onto non-target surfaces.

DO NOT apply to people, pets, livestock or sources of electricity.
DO NOT apply as a space spray or broadcast application.

DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs) or in areas where these plants are grown.

FOR INDOOR USES:

ANTS, COCKROACHES, CRICKETS, EARWIGS, FIREBRATS, SILVERFISH, SOWBUGS, SPIDERS, RED FLOUR BEETLES, AND RICE WEEVILS: Thoroughly treat inside building surfaces including cracks, crevices in walls, floors and ceilings, beneath furniture (e.g. shelves and drawers). For ants, cockroaches, silverfish, sowbugs and spiders, also spray along door sills, baseboards and openings around sinks, drains and pipes, behind stoves and

refrigerators, around window frames, in localized areas of attics and basements and around interior foundations. For silverfish, also spray cracks and crevices in bookcases. Remove all objects before treatment of bookcases where books, clothing, toys, towels and other items are stored. Treated bookcases must be dry before replacing stored items. For ants, also spray trails, nest and points of entry. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. **[CARPET BEETLES:** Spray edges of carpeting and under carpeting and rugs for approximately 10 seconds duration. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. **FLEAS (ADULT AND LARVAE) AND BROWN DOG TICKS (ADULT AND NYMPHS):** DO NOT apply to furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, moldings, window and door frames. Pet bedding may be entirely treated with this product or replaced with clean, fresh bedding after other listed areas are treated. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

DO NOT SPRAY PETS WITH THIS PRODUCT. Only treat pets with products specifically registered for use on that type of pet. For effective flea and tick control indoors, clean any area used by the pet. Cleaning the areas includes vacuuming floors, carpets, furniture, etc. (discard vacuum bag after use) and washing the pet's bedding, living quarters, and surrounding area. **CLOTHES MOTHS:** Remove all objects before treatment of bookcases, closets or other types of storage furniture where clothing, toys, towels and other items are stored. Remove any infested articles from storage, brush thoroughly and air for several hours in sunlight, if possible. Apply spray to empty chests, closets, bureaus and other storages, directing the spray into cracks, joints and crevices. Treated furniture must be dry before replacing stored items. Treatment must only be repeated after 7 days if pest problem persists or reoccurs. After airing, infested articles may be treated lightly, keeping nozzle at least 90 centimeters (three feet) from fabric to avoid staining. Allow articles to dry before handling and launder cloths before wearing. **HOUSE FLIES:** Spot treatment only. Spray inside building surfaces around points of entry (e.g. screen frames, windows and doors). Treatment must only be repeated after 7 days if pest problem persists or reoccurs. **FOR INDOOR PLANTS: APHIDS AND WHITEFLIES:** Spray surfaces of upper and lower leaves of plants until damp, but not to the point of running off. Safe for use on most plants. Before treating delicate plants, spray only 1-2 leaves and wait 2 days to be sure the plant leaves are not damaged.

BED BUGS: Apply spray directly to inside building surfaces including, cracks and crevices in the walls, floors and ceilings; along and behind baseboards and moldings; and localized areas of walls behind and floors beneath furniture(e.g., bed and nightstand). Do not apply to the mattress, headboard, footboard or other furniture. To enhance effectiveness of this product, apply this product directly to bed bugs where possible. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

FOR OUTDOOR USES:

ANTS, CRICKETS, FLEAS, SPIDERS, SOWBUGS AND BROWN DOG TICKS:

For use outdoors on the exterior surfaces of buildings and on patios, porches and decks. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where

listed pests enter (e.g., screens, doors, window frames). This product may also be applied to garbage cans and localized areas of patios, porches and decks. For ants, spray onto ant trails, into ant nests and points of entry. Treatment must only be repeated after 14 days if pest problem persists or reoccurs. [Application to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Always pre-test a small inconspicuous area to be treated, for colour fastness and staining. Pre-test siding. Evaluate 30 minutes after test application for potential staining. Never apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of day. Do not apply to tapestries, wall paper or similar materials that may stain.]

HOUSE FLIES: Apply as a spot treatment only. Spray spots on outside surfaces of foundations, under eaves troughs, around light fixtures, and places where house flies enter (e.g., screens, doors, window frames). Houseflies will be killed when they land and crawl on the treated surfaces. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

TO KILL GARDEN PESTS: ON FLOWERS AND ORNAMENTALS. Sucking Insects: Exposed Thrips, leaf-hoppers, aphids. Chewing Insects: Leaf Eating Caterpillars. For listed pests on Asters, Azaleas, Begonias. Chrysanthemums, Dahlias, Delphiniums, Gladiolas, Irises, Marigolds, Petunias, Roses, and Snapdragons, Evergreens, small Deciduous trees, shrubs and vines: Carefully spray with slow sweeping motion keeping 30 cm to 45 cm away from the plants to avoid wetting the foliage. A light spray kills pests effectively. Spray only when air is still and temperature is under 32°C. Do not spray in direct sunlight - early morning or evening preferred. Use with caution on young plants and new growth. Insects must be contacted by spray to be killed.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not use on humans or animals. Do not use as a space spray. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Cover fish bowls and remove pets for one hour when spraying rooms. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. After use, wash all surfaces that may contact food. Avoid contact with skin, eyes, clothing. Avoid inhalation of spray. Wash after using. Keep from freezing. Do not use this product in or on electrical equipment due to possibility of shock hazard. Do not use on MaidenHair Ferns. Do not use on vegetable crops.

FIRST AID: In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.
