Space Spray: Kills flying insects in barns, milking parlors and milkhouses. Cover milking utensils to prevent contamination from spray and dead insects, do not spray milking equipment (any treated surface that may contact food or feed products should be washed thoroughly with potable water after spraying and before reuse). Do not use in rooms where milk is processed, handled or stored. Direct spray upwards to all parts of the room especially windows and other light sources. Apply at a rate of 1 to 2 seconds per 30 m³.
