**DIRECTIONS FOR USE:**

To be used only in the manufacture of a plant growth regulator, which is registered under the *Pest Control Products Act*.

**PRECAUTIONS:**

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL: May be hazardous if swallowed, inhaled, or absorbed through the skin. Avoid contact with skin, eyes and clothing. Wash hands thoroughly with soap and water before eating, drinking or smoking and change to clean clothing. Keep away from domestic animals. Do not contaminate any body of water. Avoid contamination of feed seed, fertilizers and foodstuffs. Store product in cool dry place. Do not reuse empty container

**FIRST AID:**

**If in eyes:** hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice
