DIRECTIONS FOR USE

For use only in the manufacture and formulation of products registered under the *Pest Control Products Act*.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

May cause moderate eye irritation. Harmful if inhaled or absorbed through skin. Avoid contact with eyes, skin, or clothing or inhaling dust or spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. This pesticide is toxic to fish. FIRST AID

If swallowed

If on skin or clothing

If in eyes

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and *Pest Control Product* Registration Number with you when seeking medical attention.
