On wide areas, two or more strips may be needed, spaced about 10 cm and applied in a zig-zag pattern. On horizontal surfaces, leave gaps to allow water run-off. To facilitate removal, apply on water proof masking tape or similar material. This cartridge must be used in caulking guns. The repellent may be removed from hands or tools by a petroleum solvent.

Do not reuse empty container. Securely wrap empty container and discard in household garbage.
